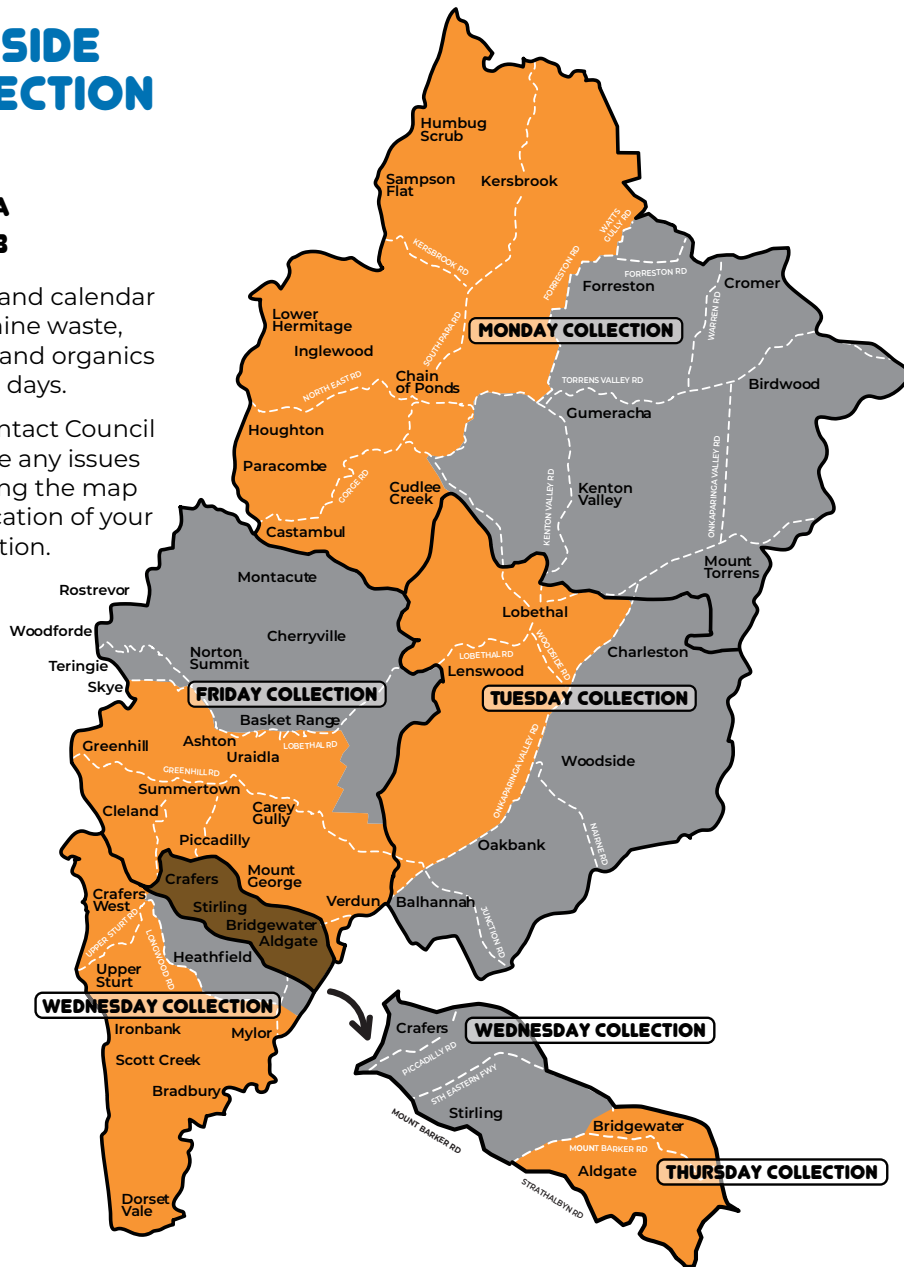


KERBSIDE COLLECTION MAP

- Green organics bin (fortnightly)
- Yellow recycling bin (fortnightly)
- Blue general waste bin (weekly)
- No collection - all collections move to the next day for the remaining week.
- Public holiday - collection as usual.

Bins should be placed 1 metre apart at kerbside by 6am on your collection day. Remove bins from verge within 24hrs of collection.

Collections may be delayed on catastrophic and extreme fire danger rated days of 75 or above. Please leave your bins out until collected.
